### 4. New Information

#### 4.1 Requesting Invitation Letters

In the event that an invitation letter is required to obtain the appropriate entry visa, the Organizing Committee asks that the Head of Delegation submit an email request to events@flyxp.com. The request should include full names of those requiring the invitation letter and any additional information necessary to obtain the visa. If the invitation letter must be issued by the USPA, please also indicate this in the email request.

#### 4.2 National Anthem and Flag

The FAI sporting code requires that each delegation must bring its own national flag and its national anthem in a MP3 format to be used in ceremonies. The recommended flag size is 100cm x 150cm.

Please turn in your flag to the front desk by April 9 before noon so we are able to put them on poles to prepare for the opening ceremony.

Each NAC should also email the national anthem in mp3 format to <u>events@flyxp.com</u> before April 8. The audio should be a maximum of 80 seconds in length.

#### 4.3 Anti-doping Program

The Anti-Doping Program may take place at the event. If so - the doping tests are carried out by the official Anti-Doping organization or sample collection provider recognized and approved by World Anti-Doping Agency (WADA). The selection of athletes would be according to the 2021 FAI Anti-Doping Rules, which are based on 2021 WADA Code and are available at <a href="https://www.fai.org/anti-doping-rules-procedures">https://www.fai.org/anti-doping-rules-procedures</a>. After receipt of notification until arrival at the point of doping control the selected competitors will be always accompanied by a chaperone assigned by the sample collection authority. The selected competitor may be accompanied by a person of their choice (team doctor, coach or head of delegation). If the Organizing Committee does not provide participants with accreditation with the photo on it, the selected athlete will be required to provide a valid passport or identity card at the point of doping control.

Note: Please carefully plan a departure date and time after the competition taking into the account that you may be chosen for the Doping Control.

#### 4.4 Accommodations and Transportation for Judges and Official Staff

The judges and official staff will be staying in the following airbnb housing: The FAI Controller, Jury, and Jury President will be staying at <u>Cozy Fort</u> <u>Liberty</u> (approximatly 7 minutes drive).

Intime Scoring, Meet Director, and Chief Judge will be staying at <u>Charming Fayetteville</u> (approximately 20 minutes drive).

All other judges and staff will be at the foloowing house: <u>Raeford Home +</u> <u>Bonus</u>, <u>Fort Liberty Haven</u>, <u>Family Friendly Raeford</u> (approximately 9-20 minutes drive).

Rides for judges and official staff will be via shared group rental cars. This includes the transportation to and from Raleigh-Durham International Airport and Fayetteville Regional Airport. 

Raleigh-Durham International Airport to Paraclete XP Skyventure (190 Paraclete Drive Raeford, NC 28376)



- Get on I-40 E from Aviation Pkwy
  - Head East
  - Continue onto Trade Drive
  - Turn Left onto Cedar Fork drive
  - Turn Left onto Airport Blvd

• Use the left 2 lanes to merge

onto Aviation Pkwy via the ramp to I-40 E/Raleigh


• Slight right onto the ramp to Raleigh

- Get on US-401 S in Fayetteville from I-40 E, I-95 S and I-295 S
  - Merge on to I-40 E
  - Keep right to stay on I-40 E,
- follow signs for Benson/Wilmington
- Take exit 328A to merge onto I-95 S toward Benson/Fayetteville
  - Take exit 58 toward I-295

S/US-13 N/Newton Grv/Ft Bragg

- Merge onto US-13 S
- Continue onto I-295 S
- Slight right to merge onto US-401 S
- Follow US-401 S to your destination in Hoke County
  - Merge onto US-401 S
  - Turn right onto Brock Rd
  - Turn right onto Paraclete Dr
  - Destination will be on your right

Fayetteville Regional Airport to Paraclete XP Skyventure (190 Paraclete Drive Raeford, NC 28376)



- Head east on 2260/Airport Rd toward Control Tower Rd
  - Take Camden Rd and Stoney Point Rd to Brock Rd in Hoke County
  - Turn right to stay on 2260/Airport Rd
  - Continue onto Black and Decker Rd
  - Continue onto Mid Pine Rd
  - Use the left 2 lanes to turn left onto Camden Rd
  - Slight right onto Rockfish Rd
  - Continue onto Stoney Point Rd
  - Turn right onto Lindsay Rd
  - Turn left onto US-401 S
  - Continue on Brock Rd to your destination
  - Turn right onto Brock Rd
  - Turn right onto Paraclete Dr
  - Your desitination is on your right
